As per Q4 business updates, Sequentially, crude steel production fell 1% from 6.87 MMT posted in Q3 FY24. Production of Indian operations stood at 6.54 million tonnes during the quarter, registering a growth of 3% YoY and a decline 1% QoQ with capacity utilisation level stood at % for Q3 FY24. The firm said that JSW Steel USA – Ohio reported better volumes on QoQ as well as YoY basis. Production of JSW Steel USA – Ohio in Q4 FY24 was at 0.25 million tonnes, (up 19% YoY and 3% QoQ). The company achieved combined production of 26.68 million tonnes as against its guidance of 26.34 million tonnes, which is a 101% achievement.
