Key concern: Management commentary on demand, large deal wins and pipeline, discretionary spending cut, margin impact on mega deals, reasons for senior management attrition after multiple senior leadership exits and the effective date for wage revision, communications and banking verticals outlook. HCLTECH	HCL Technologies Limited	The company is expected to report soft set of numbers on account of slowdown in the demand environment due to economic growth concerns in the US and Europe. It may report muted revenue growth due to macroeconomic challenges in the BFSI and hi-tech sectors, delayed discretionary spending. Operating margins are likely to remain under pressure YoY but sequentially it may improve slightly due to wage hike deferrals and operating leverage. Key concern: management's comments on the demand scenario of BFSI and Hi-tech segments, update on project delay, deferral, or cancellation due to macro uncertainties and EBITDA margins.
