Industry & Fund Update

Industry & Fund Update

Debt mutual funds attracts Rs 1.06 lakh crore in FY23; liquid funds account 60% inflow After massive outflow in March, debt-oriented mutual funds witnessed a sharp turnaround in April as they attracted Rs 1.06 lakh crore with liquid schemes accounting for 60 per cent of the inflow. Barring credit risk and banking and PSU fund categories, all the other segments witnessed net inflows and expectedly, categories having shorter maturity profiles were the biggest beneficiaries, the data with the Association of Mutual Funds in India (Amfi) showed. Going ahead, debt mutual funds are likely to witness a decline in inflows since the tax benefits from indexation are not available from April 1 onwards, V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said. According to the data, debt mutual funds witnessed an inflow of Rs 1.06 lakh crore in April as compared to a net outflow of Rs 56,884 crore in the preceding month. The huge inflow has pushed the assets under management (AUM) of fixed income funds or debt funds from Rs 11.81 lakh crore in March to Rs 12.98 lakh crore last month. In terms of categories, liquid funds received the highest net inflows of Rs 63,219 crore, accounting for 60 per cent of the total flows of debt funds during the month under review. This was followed by the money market fund category that attracted Rs 13,961 crore and ultrashort duration fund that saw a net infusion of Rs 10,663 crore.

SBI Mutual Fund launches SBI S&P BSE Sensex Index Fund

SBI Mutual Fund has announced the launch of the SBI S&P BSE Sensex Index Fund, an open-ended scheme tracking the S&P BSE Sensex Index. The new fund offer of the scheme is open for subscription and will close on May 24. The scheme will commence for sale/ repurchases within five business days from the date of allotment. The performance of the scheme will be benchmarked against S&P BSE Sensex TRI. The scheme will be managed by Raviprakash Sharma. The scheme will invest 95-100% in stocks comprising the S&P BSE Sensex Index and 0-5% in government securities including tri-party repo and units of liquid mutual fund. The scheme will adopt a passive investment strategy. The scheme will invest in stocks comprising the S&P BSE Sensex Index in the same proportion as in the index with the objective of achieving returns equivalent to the Total Returns Index of the S&P BSE Sensex Index by minimizing the performance difference between the benchmark index and the scheme.

Baroda BNP Paribas Mutual Fund launches Baroda BNP Paribas Value Fund

Baroda BNP Paribas Mutual Fund has announced the launch of Baroda BNP Paribas Value Fund, an open-ended equity scheme following a value investment strategy. The new fund offer of the scheme is open for subscription and will close on May 31. The scheme will be managed by Shiv Chanani. The scheme will be benchmarked against the Nifty 500 Index. HDFC Mutual Fund launches India's first defence fund

HDFC Asset Management Company Ltd on Tuesday announced the launch of the country's first mutual fund focussed on defence sector, a move that will provide investors an opportunity to participate in growth potential of this space. The new fund offering (NFO) of HDFC Defence Fund, an open-ended equity scheme, would open on May 19 and close on June 2, HDFC AMC said in a statement. The fund will invest at least 80 per cent of its net assets in defence and allied sector companies. Defence and allied sector stocks include stocks forming part of aerospace and defence; explosives, shipbuilding and allied services. "In a multipolar world, defence expenditure globally is set to increase as countries enhance their defence capabilities. Self-reliance in defence led by strong R&D (Research and Development) focus and enhancement of manufacturing capabilities creates opportunity for Indian companies to serve domestic market as well as tap large export potential. This could offer a multi-decadal investment opportunity," said Abhishek Poddar - Fund Manager - Equity and Senior Equity Analyst, Dealing and Investments at HDFC AMC. The asset management firm said that the scheme will invest in companies with good quality management with demonstrated track record and aims to achieve diversification by following a multi-cap strategy. The fund's focus would be on growth and quality at reasonable valuations by investing across large, mid and small cap stocks.

Quant Mutual Fund launches Quant Business Cycle
